- 11. Status of extending the half day PD days (Mar and May) Grievance Filed was denied by WRSD.
 - a. More information will be gathered regarding the time frame required for all members
 - b. Sam felt that the district would "win" if this went to arbitration
 - c. Ryan Z. will create a shared document to start tracking what disciplines are doing on PD days
 - d. Motion made to move the grievance forward (level 3): not passed

New Business:

- 1. <u>Course approval and reimbursement</u> one page "how to" will be given to HOD to put in the drawer at each school along with the forms.
 - a. Gold Cardstock should be placed in the mailroom with the form needed
 - b. White copies are for members
 - c. Documents will also be available on website and referenced in upcoming newsletter
- 2. Motion on next step for PD grievance following WRSD denial. Further action beyond SC is unlikely to be settled prior to the dates as arbitration can take months to schedule
 - a. See old business above
- 3. Schedule a State Funding Forum with surrounding districts
 - a. Motion made for WRSD to host a forum for surrounding on increasing state funding: passed
- 4. Admin proposed the use of WREA PD funds to cover cost of Mindfulness Course in the spring (\$200 each for up to 30 for a total of \$6000) Those attending would need to agree to use their allotted PD money for the course. This would be included on the registration form.
 - a. Motion made and seconded that the district should not fund the course: failed
 - b. Motion made and secoMOvended that WREA allow members to use \$200 of their PD fund allotment to register for the Mindfulness Course: failed unanimously based on concerns that members have not asked for this and at the recommendation of PD committee members present and agreed by the HOD, we do not want to set precedence that the district begin to suggest how best to use these funds.
- 5. Any future locations for PD should include ADULT furniture (motion to pass a resolution to present to school committee)
 - a. Tabled until next month (Heidi will write something up that also includes language for art teachers meeting in art rooms, etc.)
- 6. LCU Money Market account rules have changed and WREA is getting charged fees for exceeding the number of convenient transactions per month. Kim and I will open a checking account to allow us to write checks for other expenses while using the existing account to accept direct deposit dues from WRSD, pay officer stipends, unemployment insurance and the MTA/NEA. (motion)
 - a. Motion made and seconded that Kim and Heidi will move \$10,000 from money market to new checking account: passed
- 7. School Committee has not fulfilled the contract language issue related to adding educators and staff to the existing bullying clause. A grievance will be filed.
- 8. Motion made to create a petition that will be presented to the school committee regarding concerns about PD such as the scheduling, contract wording and the district's interpretation of it, the days the WREA is supposed to have input on, and their decision to extend time of half days after the calendar was approved.
